Permittee is responsible for adherence to all of the terms and conditions of this permit. If the location specified above is a public place, permittee shall further be responsible for cleaning up any bottles, cans, cups, containers, or other associated debris which may be deposited thereon in the course of the sale or consumption of alcoholic liquor or malt beverages pursuant to this permit.
